ARTICLE 2 OF THE EMINENT DOMAIN PROCEDURE  
LAW FOR THE BEECHWOOD ROAD DRAINAGE  
IMPROVEMENT PROJECT

NOTICE IS HEREBY GIVEN THAT, pursuant to Article 2 of the Eminent Domain Procedure Law ("EDPL"), the Town of New Hartford Town Board ("Town Board") will hold a public hearing on the 10<sup>th</sup> day of April, 2013 at 7:00 P.M. or as soon thereafter as reached in the regular course of business, in Butler Memorial Hall, 48 Genesee Street, New Hartford, New York for the purpose of describing the proposed construction of Stormwater improvements and the acquisition of a permanent easement approximately across the property located at and known as 28 Wills Drive, New Hartford, NY (portion of Tax Map No. 339.011-1-92) and an additional temporary easement for the purpose of construction of Stormwater improvements.

The Public Hearing is intended to inform the public about the proposed acquisition of the easement in the above-described real property and to outline and review the public purposes and uses to be served by the Project, the potential impact of the Project on the environment, and examine reasonable alternatives.

The property owner(s), any entity with an interest in the property, public and property owners in the vicinity of the Project area are invited to attend the Public Hearing to present oral or written statements or other documents concerning this proposed Project.

Any property owners who may wish to challenge condemnation of their property via judicial review may do so on the basis of issues, facts and objections raised at such hearing.


